2.1.0 Overview

1.2.0 A Study of Attitude of VIII Standard Students towards Rights of Children-Rucha Desai.

From the present study it was found that students of VII th standard had moderately favorable to highly favorable attitude towards Rights of children in case of control group. Whereas scenario is reverse in case of experimental group showing the positive impact of implemented education programmed on rights of children in shaping the attitude of students. It has significant positive impact on students of experimental group.

Findings;

- 1 The teachers were aware of child rights at satisfactory level.

- No significant difference in the child rights literacy level of teachers having the experience of 10 years and above 10 years.

Education for all: Handicapped Children Act is an unusual piece of legislation in that it has continued to enjoy bipartisan support in an era of shrinking federal investment in such programs.

Judith Singer and John Buttler report the findings of a study on the act's implementation in five diverse school districts across the country, conducted during the existence. The process of equilibration between federal demands and the local capacity to respond provides a central focus for the authors as they ask how, and how well, the school has functioned as agents of social reform. While they find that both significant transformation of attitude and social reform have occurred, they also point to inequities whose roots in the social fabric make them difficult for the school alone to overcome.

For Teachers

Teachers with 17 years experience have high awareness about child rights.

Awareness of Toank and Ajmer Districts

Study found that regularity in attendance, writing skills; other social, economical factors were impacting learning of students.

Effects of social and economic factors on students decision taking.
