It is referred as educational aspiration. It is considered as a concept referring orientation towards educational goals. The levels of education are closely linked to educational aspiration. The higher the level of education the higher is the educational aspiration.

Aspiration as a cognitive state motivate on drive, young people to strive for academic success, (Khoo and Ainsley 2005) level of aspiration refers to the degrees of quality of performance which individual desire to achieve (2000). It is the index of an Individual's ability for his future performance on the strength of his past experience his ability and capacity the efforts that he can make the goal. It Encourages and energizes the individual to achieve educational goals an Individual set for himself/ herself-adoring to Sirin Diemer Jackson and Howell. (2004). Aspiration has been defined as the educational and vocational dreams that student have for the future. 'According to Harlock (1973) "Aspiration means a longing for what one has achieved with advancement on it's as its end."

Educational Aspiration on the other hand focus on the desire to accomplish the goals or to succeed in particular educational fields. It represents a relatively abstract idealistic plan a person desire on hope to achieve high levels of education (Bohon et al. 2006, Reynolds and Pemberton 2001trusty 2002).

Aspiration represents idealistic preferences for the future so... in Some degree they might reflect. Student recognition of the social and economic importance

of higher education rather than their personal desire to attend (Bohun al. 2006. 2008). Educational aspirations are influenced by multiple Intrapersonal and systemic factors. (Gottfredson 2002). Some Individual factors related to student aspiration include their level of Intrapersonal skills Self-reliance self-control Self-concept and low maturity responsibility, economic status (SES). The level of family's engagement in their children's education level of parental education etc. Frank (1941) defined level of aspiration future as "the level of future performance in that task which an individual aspiration to words his possible" attainments in a hierarchy of difficulties that he is likely to face, His level of aspiration is described to be most attractive orientation on the continue of difficulty in relation to the goals. The aspires to achieve "Parents' educational and economic background have a significant effect on their children's education. Children from well of Socio- economic background have fair chances of having better, educational aspiration as it influences student's higher education Selection. Becker Tomes (1979) assert that wealthy and well-educated parents provide favorable learning environment and better education. "For most children to be with what a daily basis because this is how the child lives and this is how he understands his life. "The essential ingredient in most children's success in School is a positive relation to his parents. (Bettelheim 1987).

#### 1.2 NEED AND SIGNIFICACE OF THE STUDY

So Researcher takes the study. We also find out the result in relation to socio class status and educational Aspiration among student of secondary school.

### 1.3 STATEMENT OF THE PROBLEM: -

#### 1.4 OBJECTIVE OF THE STUDY: -

# 1.5 HYPOTHESIS-

- 3. There is no significant difference between government and private secondary school students in relation to their socio-economic status.
- 4. There is no significant difference between secondary school student in educational aspiration based on gender.
- 5. There is no significant difference between secondary school student in socioeconomic status based on gender.

# **1.6 DEFINITION:**

# • Educational Aspiration:

The concept of educational aspiration has been explained differently by different educationist and psychologists but some of the definitions are as under. In the words of JAMES DREVER an quoted by Sharma and Gupta [1980] the term ''level of aspiration is best explained as a frame of reference involving self-esteem as standard with reference to which an individual experiences his sense of achievement. According to English Dictionary (1968) Level of aspiration may be defined as the standard by which failure or as being up to what he expects of himself." Wood (1959) as quoted by Singh (1975) has described "Level of aspiration as the level of performance for the goal that a person or hopes to reach in a specified activity High level of aspiration is essential for accomplishing one's aim without strong aspiration it is not possible for a person to reach his goal.

Hurlock (1967) has defined aspiration" as a longing for what is above one' achievement level."

In other words, aspiration means the goal an individual sets for himself in a task which has intense personal significance for him or in which his ego is fully involved.

Bissell (1977) defined "Educational aspiration or expectations as individuals expressed desire to continue his formal schooling beyond high school". So, the term aspiration was defined as fantasy level with or without any touch of reality. The term level of aspiration involves the estimation of one's ability for his/her future performance on the strength of his/her past experience, his/her ability and capacity. Here researcher takes a term educational aspiration for study because educational aspiration helps an individual to achieve his/her goal set by him/her. Educational Aspiration depends on awareness about educational mobility. Opportunities and one's interest among known educational opportunities.


